#### **4.2 2025 Arts, Culture, Heritage Grant Applications**

The Chairperson responded to a query regarding whether improvements to a facility meet the criteria for grant funding eligibility.

Discussion ensued regarding perspectives on the approach for choosing grant recipients included evaluating the impact of the event, ensuring fair allocation within the region, providing a reduced amount than requested to allow for a greater number of grants, refraining from supporting applications that have previously been awarded grants, and basing funding on the merit of the application.

H. Erasmus, Manager of Communications and Culture, responded to queries regarding the present status of the grant funds and the annual interest earned and noted that the Board approved \$50,000 for the grant budget this year.

Discussion ensued regarding applications that received scores lower than eight, in terms of their alignment with the cultural plan, as well as those that received scores under six for permitted use, in addition to those that achieved high scores.

The Chairperson responded to a query concerning the publication of grants in the media prior to official notification and advised that the committee is advising the Board to approve these grants, although the Board retains the discretion to approve or reject them.

H. Erasmus, Manager of Communications and Culture, advised that Administration can communicate with the applicants after the meeting today to inform them of their recommendation to the Board for approval and to provide clarity on the process.

Discussion ensued regarding the presence of media during the grant adjudication process, with concerns raised about how this might impact the dialogue and affect future partnerships with cultural organizations. It was also noted that if the Regional District Board intends to conduct grant adjudication at the community level, a clear process should be established to allow these discussions to occur in private, ensuring open and candid conversation.

C. Ramsay advised that she would advise the Board of the committee's concern about the presence of media during the grant adjudication process at the June 19, 2025 meeting.

#### **Mackenzie Community Arts Council Grant Application for Flooring**

Discussion ensued regarding the Mackenzie Community Arts Council Grant Application for \$9,921 to replace the flooring, including that the Mackenzie Arts Council offers valuable services to the community, engages in collaboration with other local entities, aligns with the cultural plan, is the sole application submitted in the community, and addresses a significant need for the services they provide.

Discussion ensued regarding the Northern BC Queer Connection Society Grant Application of \$7,650 to support a Pride Picnic, including that the initiative is valuable and deserving of support, but some concerns were raised about its heavy emphasis on Prince George.

Discussion ensued regarding Theatre Northwest Grant Application for \$10,000 for accessibility upgrades and the committee expressed varied opinions on endorsing this, while also voicing concerns about the potential difficulty in securing funding for female hygiene products and a change table, and indicated a willingness to offer a grant to facilitate the purchase of these items.

It was also observed that, in contrast to previous years when there were not enough applications to allocate all available funds, this year saw a strong response. The committee expressed their appreciation to the Regional District for its continued support of arts and culture in the region.

Discussion ensued regarding revising the cultural plan in response to the increased number of applications, including a review of the eligibility criteria and a potential increase in the total grant funding available.

- Prince George Community Band for \$6,000 for supplies, equipment and event hosting
- Prince George Metis Community Association for \$10,000 for a community event and a Louis Riel Day celebration
- The Exploration Place for \$10,000 for retractable steps
- Theatre Northwest for \$10,000 for flooring
- Two Rivers Gallery for \$7,334 for Community Art Days

<b>Purpose:</b>	To provide grants for the benefit of arts, culture and heritage programs and services within the Regional District
<b>Authority:</b>	<i>Local Government Act</i> , Section 263 Regional District of Fraser-Fort George Cultural Endowment Fund Establishment Bylaw No. 3039, 2017.
<b>Scope:</b>	This policy shall apply to those organizations as defined under Bylaw No. 3039, 2017, who are seeking financial assistance from the Regional District under the Emergency Funding Grant Program and the Arts, Culture, Heritage Project Grant Program, as established under Bylaw 3039, 2017.

<b>Definitions:</b>	<b>“Board of Directors”</b>	<b>means</b>	the Regional District of Fraser-Fort George Board of Directors

The building has since been used as a community hub engaging all ages in workshops, performances, conferences, meetings and gatherings. Our mission is to enrich the lives of the people who reside in the Robson Valley and Dunster with a welcoming, inclusive space to celebrate the arts, culture and our community.

Past programming has involved senior led workshops, playgroups and support for young mothers, food creations, seed saving, food security, live music and visual art.

This year we will work with Take 5 Films for the Youth Film camp again, creating 3 short films with youth ages 11-18 years old, featuring localized facilitators from Dunster and Prince George.

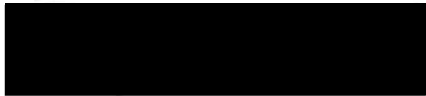

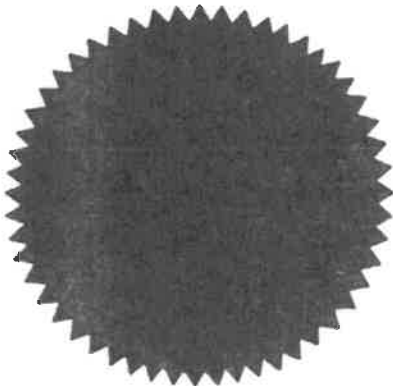

The River is one of the world’s great wild salmon rivers – an ecological backbone for dozens of First Nations and communities. The River’s watershed is home to at least two-thirds of BC’s people.

The River is in need of us. Habitat fragmentation, industrial pressures, and climate impacts are affecting its health.

## PROJECT:

The following Arts Trio is a way for the residents of and the visitors to the RDFFG, Area H, to engage in honouring, celebrating, protecting, and strengthening reciprocal relations with the River.

### 1. “I Am A River” Song (original song written in the River’s headwaters bio-region)

Gather a river choir.

Record the song (local sound engineer).

Upload the song to the FHA’s and Fraser Riverkeepers Society’s websites.

Extend an invitation to the communities and regional districts downstream to create songs/instrumental pieces, dedicated to the River, to also upload.

This is a way to unite the First Nations and communities who share the River and its watershed. It is also a way to fund-raise for protection and stewardship efforts.

Extension possibility – A provincial album – “This River Runs Through Us”

### 2. “I Am A River” Booklets/Pamphlets

(Song lyrics are on one side; facts about the River on the other side. High School student artwork on both sides.)

Unfolding the 8 panels of this booklet reveals the River from the mountains to the ocean.

This booklet/pamphlet will be informational and connect to the organizations. The aim is for them to be available in each Area H community – Mt. Robson, Valemount, Tete Jaune, Dunster, McBride, Crescent Spur, and Dome Creek.

### 3. Love Letters, Gratitude Notes, and/or Reciprocity Promises to the River

At least one felted salmon-motif basket, made by a local artisan, will be available in each Area H community, along with the booklets.

Anyone interested can take a template and write a note and place it in the basket.

We are also looking into the option whereby an upload to a digital site is available.

Create a physical book of contributions to be in each community in Area H.

## Timing:

The goal is to have projects 1 and 2 completed by early June. Project 3 would be an ongoing project until Thanksgiving weekend.

From the headwaters region of “this river who runs through us”, an opportunity exists to take the lead in creating and participating in arts projects that will support and bring voice to the River. We will invite the First Nations, communities, and regional districts of the River’s watershed downstream of us to participate in creating songs to add to a collection and to engage in other arts initiatives/events with a focus on the River. This project has the potential to more deeply connect a province.

Area H is a visiting place for national and international visitors. They, too, will have an opportunity 1) to participate in one of the projects directly – writing a love letter, a gratitude note and/or a reciprocity promise to the River, 2) to learn more about the River with the booklet/pamphlet, and 3) to support protection and stewardship of the River through song.

This Arts Trio will involve children, youth, adults, and the River working collaboratively and cooperatively to bring this project to fruition. The RDFFG will be known for its support in creating healthy ecosystems where healthy people and healthy communities live. It will also be known for its support of the arts in helping to create that world. The world and its peoples need every opportunity, in these times, to know how powerful we can be working together towards common goals, and the fun we can have doing so.

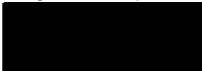

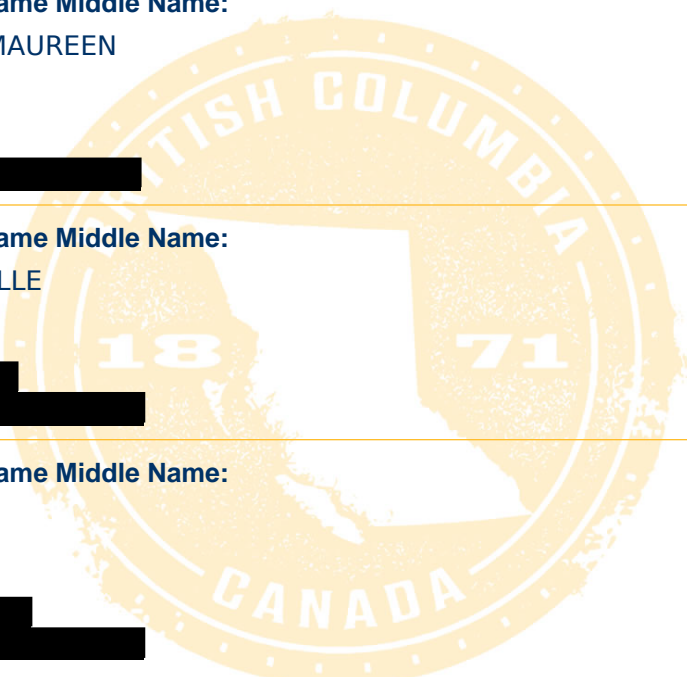

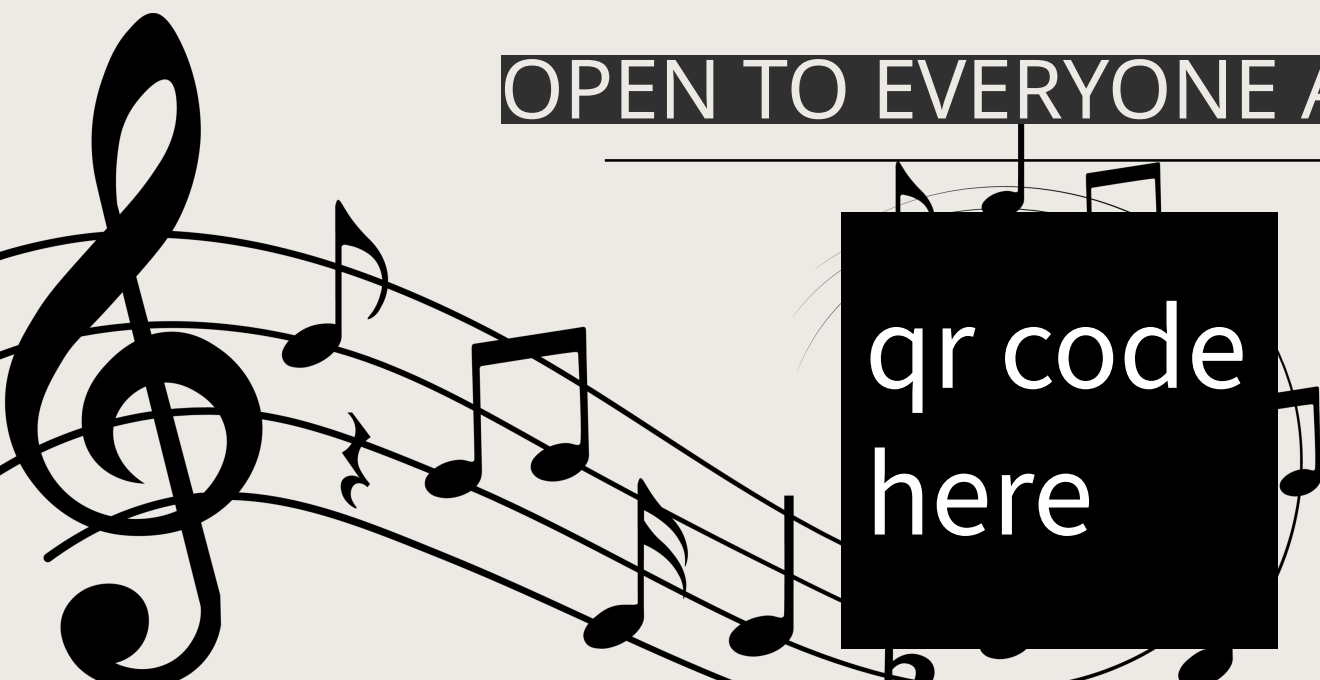

Huble Homestead is undertaking this project alone, however in the lead-up work to the creation of the website we have worked with Northern BC Archives for the scanning of the 1400 diary pages and provision of several historic photographs, as well as The Exploration Place for additional historic material. We owe special thanks to the Prince George Public Library for ensuring public access to the Fort George Herald and Prince George Citizen digital archives.

HHGPHS operates and maintains Huble Homestead Historic Site and provides daily guided tours, public event days, and educational programming from May to October. In the winter off-season, we provide in-school education programs, participate in community events, and conduct historical research that supports our heritage interpretation.

Our proposed project is the creation of a website that will allow the public to view and read the historic diaries of Albert Huble, the namesake of Huble Homestead. When the physical diaries were donated to the Society in 2020, we began a review of the 1980s diary transcriptions to correct and update them. This led to the Society staff and volunteers spending the past five years researching the hundreds of people named in the diaries, as well as annotating entries to shed light on the historical activities and context of Huble's daily records.

We wish to make this regionally-valuable research available to the public, and as such are seeking support to create a website where researchers, genealogists, students, and the wider community can view the scans of the original diaries alongside typed transcriptions and relevant explanations and historical information. The website will also include several digital exhibits that will provide historical and geographical context to the diaries.

The research, annotation, and editing of the diaries are complete, and the final stage of the project is the creation of the online exhibit. We will engage a local company to build the website.

The Cultural Plan aims to meet the cultural needs of our region, and as part of that aim, contracts HHGPHS to operate and maintain Huble Homestead Historic Site (Giscome Portage Regional Park). Our work supports the cultural vibrancy of our region by providing local residents and visitors the opportunity to learn about the past, helping to celebrate and interpret community milestones, and entertaining and educating the community. The work we do in support of these goals is founded on the responsible stewardship of the Huble house, built in 1912, and the other original and recreated buildings in the park.

The proposed website project serves a vital part of our mission outside of the preservation of the physical structures in the historic park and will add diversity to the cultural offerings within the Regional District. The historic content is intensely local to our region, with specific emphasis on Electoral Area G and the city of Prince George, and is not currently easily available to the public. The historical and geographical context provided through examining the diaries will help tell the story of our region's development in the early 1900s for both locals and non-locals.

Over the last couple years, MCAC has undergone massive repairs and accessibility upgrades to our new facility. We will be completing all of these renovations over the next year. We will have the construction of our new outdoor stage (Co-op Community Spaces Gazebo Project) with planter boxes, benches, picnic tables and a fire pit completed as soon as the ground is workable, followed by an opening celebration with music and food in the summer of 2026.

We would like to have our exterior signage in place for that event, with our current tenants (MCAC, Potter's Guild, Men's Shed) signs in place. We will then have until March 31, 2027 to complete interior improvements and hold our official Ribbon-Cutting Ceremony. We are actively seeking new user groups to populate our new facility, as it becomes fully operational. We would like to have the exterior signage completed, to include all our new user groups, our major sponsor-board, Mountain Gifts and Gallery (MCAC's storefront selling local art, music/art supplies and a gallery featuring local artists), as well as signage to signify the official commemoration of the "Herb Singh

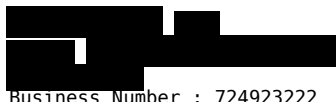

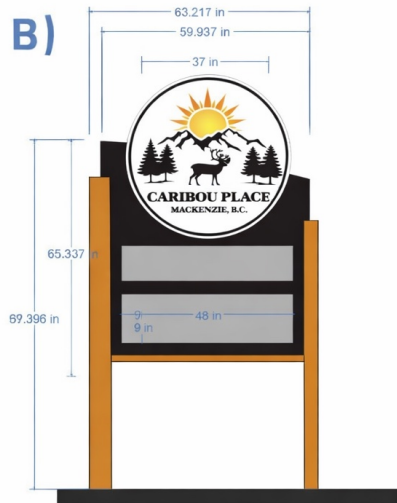
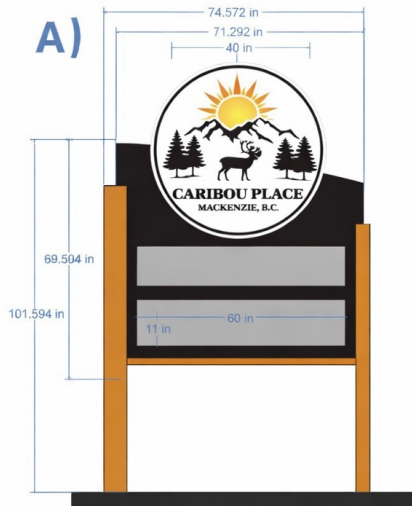

The centerpiece of the “Art Meets Tech” project is a public showcase of maker-inspired artwork that highlights how contemporary tools and technologies can be integrated into artistic practice. The exhibition will feature original works by local artists created using digital fabrication and hands-on making techniques, demonstrating new possibilities at the intersection of art, craft, and technology.

The showcase will be supported by a series of four hands-on workshops designed specifically for artists: laser engraving for artists, 3D printing for artists, CNC machining for artists, and plastic recycling for artists. These workshops are intended to lower barriers to entry for artists who may not have prior experience with maker technologies, while also providing opportunities for more experienced makers to deepen their skills and expand their creative toolsets. Each workshop combines technical instruction with guided artistic exploration, ensuring that participants can immediately apply what they learn to their own creative work.

Through these workshops, participants will gain practical experience with advanced maker techniques such as digital design and 3D modeling, inlay work, multi-color and material-aware 3D printing (including HueForge and FullSpectrum techniques), mold making, and creative plastic recycling. Artists will also explore hybrid workflows that combine tools to encourage cross-disciplinary thinking and experimentation.

The Northern BC Maker Collective (the Maker Collective) is a local non-profit organization that is the culmination of years of effort to fulfill the need for a PG-based makerspace and a central hub for our thriving maker community. We represent a collective that seeks to encourage networking, communication, camaraderie and sharing of tools amongst all interested individual makers and maker-related guilds and groups in the Prince George and Northern BC area.

Our makerspace, the Maker Station, serves as a physical community hub for innovation, creativity, and skill development, welcoming people of all ages and backgrounds.

The broader goal of the Maker Collective reaches beyond a physical makerspace, to encourage shared resources and to build community spirit amongst a wide-ranging collection of local and regional participants in maker culture. Making touches a wide swath of individuals and groups, from more traditional hands-on trades and art to music and food. Practically every aspect of life uses or creates “things that are made”. The MakerCollective aspires to foster and participate in (but not control) the connectivity that we envision springing up due to the existence of the MakerCollective and the Maker Station.

Our mission is to bridge the gap between those who make and the tools they need. Prince George is a growing community of artists, tradespeople, students, and environmentally engaged residents, yet there are limited publicly accessible spaces offering structured training in traditional and digital fabrication, sustainable material reuse, and creative technology to the broader community. 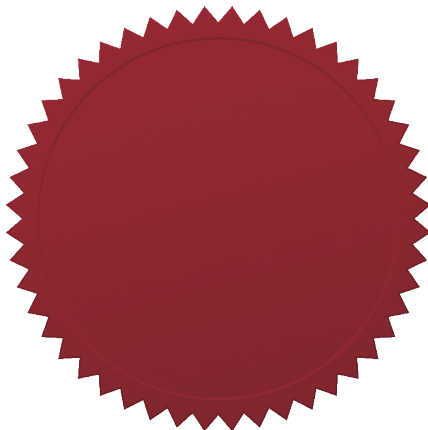

In 2026, Northern BC Queer Connection Society will coordinate with Prince George Pride Society to host the Pride Parade and Pride Picnic on the same day. In previous years, these events were held on separate days. This year, the parade route will conclude at the picnic, bringing both celebrations together for the first time. While our organizations operate independently with separate funding streams, we are intentionally aligning our efforts to strengthen the overall festival and create a more connected, welcoming, and accessible experience for the community.

Northern BC Queer Connection Society and Prince George Pride Society are the primary project partners, working together on planning and delivery. In addition, the event is supported by the Northern BC Pride Alliance, a network of Pride organizations from across Northern British Columbia that collaborate and share resources to strengthen Pride initiatives in the region. Members of the Alliance, including CNC Pride and the UNBC Pride Centre, as well as other Pride organizations from across Northern BC, are expected to participate by hosting booths and engaging with the community at the picnic. While these organizations are not formal project partners, their involvement reflects a strong regional collaboration and contributes to the overall impact of the event. As part of this reciprocal model, organizations attending the Pride Picnic will bring a regional presence to Prince George, and Northern BC Queer Connection Society will in turn participate in Pride events across the region, helping to represent and connect Northern BC communities through shared celebration and support.

2026 Pride Festival Budget Rationale

In 2025, Northern BC Queer Connection Society was grateful to receive \$2,500 through the Arts, Culture and Heritage Grant. For 2026, we are requesting a total of \$6,000 to support an expanded, collaborative Pride festival between Northern BC Queer Connection Society and Prince George Pride Society.

The requested funding will be shared equally, with \$3,000 allocated to each organization. Approximately \$1,000 will support a jointly developed parade float, with the remaining funds supporting each organization's event production needs.

This funding allows organizers to better focus on planning and delivering Pride events, rather than raising funds simply to make them possible, which directly enhances the quality of the events.

While both organizations operate independently, this collaboration strengthens coordination, increases participation, and enhances the overall impact of Pride in the region.

This increase reflects the growth of the event and the added value of a coordinated, regionally impactful Pride celebration.

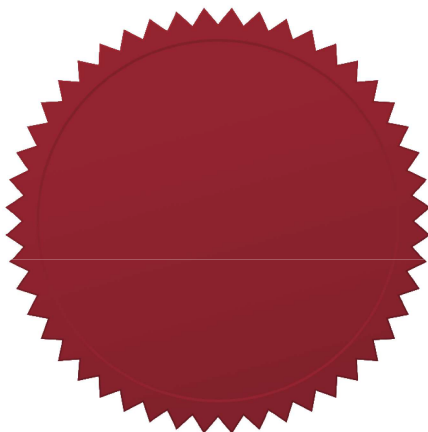

<p>The Prince George Community Band (PGCB) partners annually on several community events. The PGCB participates in the PG Remembrance Day Ceremony, providing live music before and during the program, including the playing of our National Anthem. We partner with the PG Railway and Forestry Museum during the Christmas season to provide a free family Christmas concert with a wide range of traditional and modern music.</p> <p>The PGCB collaborates with the City of Prince George to perform at the annual Canada Day celebration at Lheidli T'enneh Memorial park, where the band plays the National Anthem alongside a singer.</p> <p>The PGCB has a unique relationship with the high schools in Prince George, offering a natural extension to the music and experience playing in a high school band, to transition to playing in a higher level organization along with professional musicians. Many past and present music teachers from the Prince George high schools (as well as musicians from the PG Conservatory of music and the PG Symphony Orchestra) are members of the band, and this creates a welcoming atmosphere for young musicians to feel comfortable challenging themselves. These band teachers often spend time inviting their own teenage musicians to play with us, and we have partnered with CHSS in the past to form a "super band" and performed together. This is something that we would love to do again in the future.</p> <p>Several musicians from the PGCB have connected with other community members to form another group called the Big</p>

The PGCB was formed in 1990 to provide live music for the BC Summer Games. What started off as a small ensemble of close friends, has grown into a consistent core groups of 30-40 musicians. The band plays from September to June under the direction of the Conductor, Rob Hannigan, a local high school teacher and PG Symphony Orchestra member. Membership is open to all musicians, with no auditions required. New members are welcomed at any point during the year and are welcome to come for a few weeks to try out the music before committing to becoming a member. The band has members from across the Regional District, including the City of Prince George and surrounding areas as well as members that commute from Vanderhoof for weekly rehearsals. The PGCB rehearses on Tuesday evenings at the PG Playhouse and performs several free concerts throughout the year in multiple locations across PG. Annual membership fees to play with the band are minimal and further reduced for student members to ensure there are no financial barriers to access music in PG.

Last year, the PGCB started the 2025 PGCB Music Library Enhancement Project, which saw the purchase of 23 new music charts. The band was able to replace some old charts with missing and unavailable parts with this new sheet music. We are requesting \$1300 of this grant to continue this Enhancement Project in order to continue replacing older sheet music as well as purchasing a wider variety of music composed by Indigenous composers and artists, in order to have a better representation of all who live, work, and play on this land of the Lhedli T'enneh.

With the grant funding from last year, the PGCB was also able to start replacing some of aging percussion equipment. The band would like to continue this project and replace more percussion items, such as purchasing new mallets and cymbals with \$1000 of this grant funding.

The PGCB is also requesting \$1000 of funding to go toward the purchase of uniform shirts for new members. The band has grown considerably in the last few years and although the members who have been in the band for longer periods have PGCB shirts, most newer members have not been able to purchase the uniform shirts. Having funding to provide these shirts will allow members to have access to the same uniform as other bands, thus removing the financial barrier for all members.

Last year, the PGCB held the first Christmas concert at the PG Playhouse. In order to put on this performance, the band relied on a community donor to sponsor our concert. Without this sponsor, the PGCB would not have been able to hold the annual friends and family concert. The band would like to apply \$900 of this grant funding to the Christmas concert at the PG Playhouse in order for friends and family to continue attending the concert at no charge.

Lastly, the band is requesting \$1800 of the grant funding to purchase folding chairs for rehearsals and performances. The PGCB recently moved rehearsals to a new facility (the PG Playhouse) following the sale of the Our Saviour's Lutheran Church, where rehearsals had been held in previous years. During this move, the chairs that had previously been purchased by the band were mistakenly sold along with church equipment. The band has been using chairs provided by the Playhouse, but these chairs are very heavy and make setting up, cleaning up, and travelling to venues very challenging. New chairs would provide us with the ability to easily transport them to and from performances, as well as being easier to set up and take down after rehearsals, specially as we have many members who are currently unable to lift the borrowed chairs that we have.

In preparation for a performance, the PGCB workshops upwards of 20 pieces, selecting 10-15 per performance, upwards of 80-100 pieces of music each year for public

The PGCB offers a diverse community option that is both high quality and low cost, allowing musicians to continue playing instruments after leaving high school, or beginning a new instrument later in life. The group consists of players from all backgrounds/entry points to music, ages, playing abilities, and musical levels.

The events that the PGCB participates in draws musicians and spectators/participants from all over the regional district. The bigger events, such as Canada Day and Remembrance Day, have thousands of listeners that benefit from the use of live music, and the smaller events, such as the annual Railway and Forestry Museum performance are equally as important for the smaller pockets of Prince George.

The PGCB has experienced a huge increase in members over the past 5+ years. Up until 2020, the band averaged about 25 musicians, and the band has now grown to a consistent number of 40+ musicians every week. Luckily, this increase of musicians has led to an increase in instrumentation that has been underrepresented in the band for a long time (clarinets, bassoons, trombone, euphonium, percussion). Many members have been a part of the PGCB for long enough to now have their own children playing alongside them.

The PGCB enhances the region, providing opportunities for those who choose to live here, and for those considering moving to the region. PGCB is an active, vibrant, and friendly group of musicians celebrating art, culture, and heritage in the RDFFG. A few members wished to share why the PGCB is important and here is what they had to say:

(attach additional information if necessary)</b></p> <p>The PGCB has 5 requests for the \$6,000 grant application. The band is applying for \$1,000 for new shirts for both new and existing members, \$1,000 for percussion equipment replacement costs, \$900 to host a holiday concert, \$1,800 for the purchase of chairs for all members, and \$1,300 for new music.</p> <p>Currently, each band member must either purchase a shirt with the band emblem embroidered, or perform without a band uniform, as the band has no budget for uniforms. A grant of up to \$1000 would enable band members that do not have the funds, to wear a PGCB uniform shirt to match the rest of the members. Many new members are retirement age with a fixed income, university students with little or no income, or high school students without jobs with minimum wage jobs. This funding would remove the financial barrier associated with having a uniform to match the other members of the band.</p> <p>The band has a surplus at the beginning of the fiscal year due to having not yet spent the remaining portion of the RDFFG grant upon reporting the fiscal highlights. Any additional surplus has been earmarked for replacing minor percussion items, such as mallets, and small drum heads. The request for up to \$1,000 for percussion equipment would allow us to replace some higher value items, such as tympani drum heads that are nearing the end of their life (\$300+ each).</p> <p>In previous years, the band held a December holiday concert in our rehearsal venue at no cost. Upon moving to the PG Playhouse, the band faced the sudden cost of paying additional fees to host a holiday concert. In order to not raise membership fees in the fall, the band is requesting up to \$900 to fund this concert. The PGCB believes that music should be accessible to everyone, and this grant would enable the PGCB to continue having low membership fees as well as not charging for tickets to the holiday concert.</p> <p>The PGCB is requesting up to \$1,800 for the purchase of new chairs for band members. Many of the performances throughout the year require the band to travel to, and set up at, various venues. In addition, each week members arrive early and stay late to bring chairs in and out of storage, with not all members physically capable to do so. Purchasing chairs that are lighter, and easier to transport would help ease the time and stress associated with both of these challenges.</p> <p>The PGCB operates on a small budget of around \$5,000-\$6,000 per year, with all revenue coming directly from membership fees. Within this fiscal year, the PGCB has budgeted \$500 for new music purchases. An enhancement of an extra \$1,300 would provide the ability to purchase approximately 12 new pieces (20 * \$150 = \$1,800 [\$1,300 grant + \$500 revenue]) of music for the band. This would enable the band to purchase new selections from Canadian and Indigenous Canadian composers, as well as more modern sections. A complete set of music covering all instrumentation for the band as well as a conductor's score can cost upwards of \$150. Typical instrumentation for a concert band sheet music set includes a Conductor's Score (x1), and musician parts for: Piccolo (x1), Flute (x8), Oboe (x2), Bassoon (x2), Bb Clarinet 1 (x4), Bb Clarinet 2 (x4), Bb Clarinet 3 (x4), Eb Alto Clarinet (x1), Bb Bass Clarinet (x2), Eb Alto Sax 1 (x2), Eb Alto Sax 2 (x2), Bb Tenor Sax (x2), Eb Bari Sax (x1), Bb Trumpet 1 (x3), Bb Trumpet 2 (x3), Bb Trumpet 3 (x3), F Horn (x4), Trombone 1 (x3), Trombone 2 (x3), Baritone B.C. 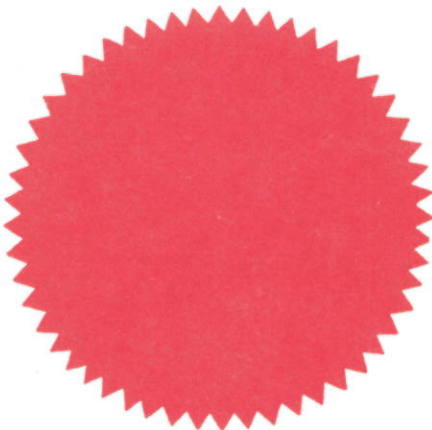

Our Events Committee Directors will engage with local Indigenous Artists will be highlighted, offering vendor tables at no cost, and information booths will offer essential prevention and intervention resources to support and connect our community.</p> <p>Our venue faciliation fee for one of our community projects directly supports the Elizabeth Fry Society as it will be held at the Fraser Fort George Family Resource center for the day. The venue for our second community gathering is in partnership with AiMHi (Prince George Association for Community Living) a non-profit organization that has supported people with developmental disabilities and their families in Prince George for over 65 years. Founded in 1957, it provides residential care, community inclusion programs, life skills training, and vocational support to foster independence and community participation.</p>

The Prince George Metis Community Association (PGMCA), is an Incorporated Non Profit Society, under the governance of the Metis Nation of British Columbia (MNBC) as a Chartered Metis Community, represents and serves over 2,500 registered Metis citizens. PGMCA advocates for and offer support to approximately 2,500 more self-identifying Metis people living in the many communities that are within our service area. The expansive geographical area that we serve in Northern BC includes the communities of Prince George, Willow River, Bear Lake, Hixon, Mackenzie, McBride, Valemount, and the rural and remote areas in between. Our mission is to act in the best interests of our community to support the health, wellness, prosperity, self-governance, and sustainability of our Metis citizens and community.

1. We propose allocating \$3000 of this project funding to host a community picnic on Sunday, August 23rd, 2026, to empower the Métis community to act against gender-based violence. The event will connect community members, increase awareness, and provide direct access to support services. Local Indigenous talent will be highlighted, and information booths will offer essential prevention and intervention resources. Led by our events and culture committee, our outreach will drive strong participation. This picnic is designed as a starting point for stronger community responsibility and long-term safety for Métis families. Bringing the Métis community together builds trust and resilience, creating a strong network for support and safety. Strengthening relationships directly addresses violence and makes families safer and healthier. The \$3000 will be utilized to support art and culture by engaging local Indigenous musicians and cultural presenters for this community gathering.

2. We propose to allocate \$7000 to partially fund our community gathering in celebration of Louis Riel Day. Louis Riel is recognized as an advocate of justice for the Métis people, but he represents much more. He helped lay the framework for minority rights and cultural co-operation, and is regarded as a founder of Manitoba. It is very important to remember Louis Riel's contribution to Canada and specifically to recall that he was executed for being a persistent advocate for the rights of his people. This is an important annual community celebration that we have hosted for many years.

Our events and initiatives support the Regional District of Fraser-Fort George's cultural vision by enhancing the region's diverse offerings. These events showcase Indigenous music, art, storytelling, and traditional practices and provide opportunities for cultural exchange and education for all.

Promoting local Indigenous artists is core to our approach and supports the District's cultural goals. By showcasing Indigenous musicians, artisans, and presenters, we honor traditional arts and stories and create economic opportunities for Indigenous creators. This local focus enhances cultural vibrancy, boosts engagement with Indigenous heritage, and raises the District's profile as a cultural hub.

By engaging local Indigenous musicians and presenters, we help raise the Regional District's profile for cultural tourists, generating economic impact. Our gatherings foster collaboration among cultural groups, drive sustained growth in programming, and build a resilient, interconnected community. This vibrancy preserves Métis heritage, supports businesses, and furthers the District's recognition for cultural excellence.

Our work drives the Regional District's commitment to Truth and Reconciliation, supporting Indigenous voices, cultural safety, and community understanding. We partner with Indigenous organizations and Elders to strengthen government-to-government relationships and foster new collaborations. 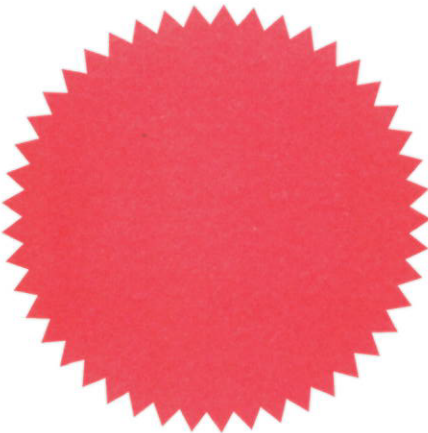

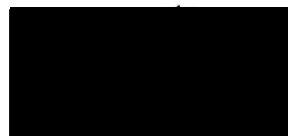

The Exploration Place (TEP) is Northern BC's largest museum and only science centre, located in Lheidli T'enneh Memorial Park in Prince George. Children and families are TEP's largest visitor demographic, and the organization serves tens of thousands of visitors annually. In 2025, TEP welcomed approximately 40,000 visitors through admissions, events, birthday parties, programs, camps, and school visits, and currently holds a record 2,070 memberships, reflecting strong and growing community investment in this institution.

This project will fund the purchase and installation of permanent, floor-anchored retractable step stools in TEP's public washrooms (womens, mens, and family/accessible) and at the public water fountain, replacing the portable plastic step stools currently in use. Portable step stools in commercial and public settings are a recognized safety hazard, presenting tipping and tripping risks particularly for young children. They also create ongoing accessibility barriers. In TEP's current configuration, portable stools placed in front of sinks and the water fountain obstruct access for wheelchair users and others with mobility challenges, who must ask staff or other visitors to move them before they can use those fixtures independently. Modern museums and science centres increasingly address this through either lowered sink installations or permanently anchored retractable step stool solutions, the latter being the practical and cost-effective approach for existing facilities. The self-retracting design of the proposed units means the step is flush with the floor and completely out of the way when not in use, eliminating the obstruction entirely and allowing unimpeded access for wheelchair users and mobility aid users at all times. When needed, the step deploys easily for children, people of short stature including those with dwarfism, and any visitor who requires a boost to reach standard-height fixtures. The units are commercially rated, non-slip, and permanently anchored to the floor, eliminating the tipping and tripping hazards of the current solution.

Funds will also contribute to the purchase and installation of impact-absorbing flooring in select high-traffic gallery areas where young children are the primary users, reducing injury risk from falls during active exploration.

The Regional District's Cultural Vision calls for residents to attend cultural facilities in large numbers and for those facilities to be recognized for the quality and diversity of their offerings. Achieving that vision depends on those facilities being genuinely safe and accessible to every member of the community.

Children are TEP's primary audience and the most frequent users of our galleries and washroom facilities, but TEP also serves a wide range of visitors with varying accessibility needs, including people with mobility challenges and parents and caregivers managing young children. Standard commercial infrastructure from the early 2000s is not designed with this full range of users in mind, and TEP's current washroom and water fountain setup reflects an older standard that creates real barriers for multiple visitor groups simultaneously.

This project addresses those barriers in a single, elegant solution. The permanent retractable step stools remove the obstruction that portable stools currently create for wheelchair and mobility aid users, while simultaneously providing safe and independent access to sinks and the water fountain for children, people of short stature, and others who cannot comfortably reach standard-height fixtures. No visitor should have to ask for assistance to wash their hands or access a water fountain, and this project ensures they will not have to.

TEP has experienced significant attendance growth since reopening, with record visitation in Spring 2026. Maintaining the safety and quality of the visitor experience for all visitors is essential to sustaining that growth and continuing to serve as a regional cultural hub that the entire community can access and return to.

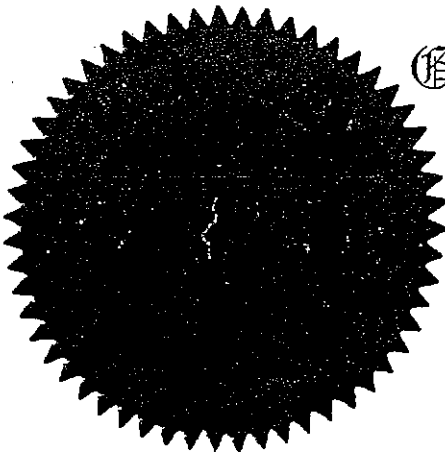

Theatre NorthWest (TNW) is a cornerstone of the arts community in Northern British Columbia, serving as the largest professional theatre in the northern two-thirds of the province. Founded in 1994, we have a rich history of producing high-caliber theatre that reflects the interests, experiences, and aspirations of our region. Our mission is to provide the citizens of North Central BC access to the same high-quality, professional theatre that is commonly enjoyed by residents of our province's larger, more southern cities.

We are preparing to undertake an important capital improvement - replacing the floor in our lobby/rehearsal space. This project will enhance the accessibility and safety of our venue for patrons, artists, and staff who are senior or have disabilities.

Our existing floor is falling apart. The boards have slid out of position creating large gaps and raised tripping hazards, which are particularly dangerous for seniors. The sliding boards also prevent our front doors from closing properly. Staff routinely need to hammer the planks out of the door frames to allow the doors to fully close. The floor is also of a highly reflective material, which poses a significant accessibility barrier. The glare coming off the floor is intense and can be disorienting and painful for anyone with a visual disability or hypersensitivity to light. Our floor currently limits who can safely and comfortably exist in our space, attend a show, or work for our organization.

We will install a new, commercial-grade floor consisting of glue-down vinyl planks. The material should be long-lasting and suitable for a high-traffic environment like ours. The planks will be securely attached to our concrete sub-floor and won't be able to slide around. The surface will remain smooth (and, therefore, safe) for many years to come, and shouldn't ever interfere with the ability of our front doors to close. Furthermore, the planks will have much lower reflectivity than our current floor. The result will be a lobby/rehearsal space that is more accessible to people with visual disabilities or light sensitivity. Anyone with those conditions will be able to more safely and comfortably navigate the space going forward. This will be an important step towards making our organization as a whole (and the broader performing arts scene in Prince George) more accessible to people with disabilities of all kinds.

Our project aligns directly with the capital upgrades priority in the Regional District's cultural plan. Replacing our lobby/rehearsal space floor has been a priority for our organization for several years. Unfortunately, limited funding has prevented us from making this upgrade before now. With fulsome grant funding, we will finally be able to replace our tired, hazardous floor and make our lobby/rehearsal space safer and more accessible for all, especially seniors and disabled people.

Our project also indirectly aligns with the collaboration priority in the cultural plan. By increasing the safety and accessibility of our venue for people with disabilities, we will be expanding the range of people who can enjoy and participate in local theatre. Participation in the arts carries many benefits for individuals, including increased social connection and a deeper sense of belonging to the community. For artists and arts workers with disabilities, having accessible employment opportunities in their local region is especially important for many reasons, including financial stability and personal fulfillment. The arts reflect our shared experiences, strengths and challenges as human beings, which helps foster empathy and compassion for others. Making the arts more accessible to all, therefore, helps strengthen our entire community.

As an important member of the arts and culture sector of Northern BC, it is our duty to continually improve the safety and accessibility of our organization to meet the needs of our large, diverse community. We have increasingly been marketing our plays as tourist attractions throughout the region, and people from all over Northern BC have traveled to see our productions. We want to make the experience of attending a play in Prince George as attractive as possible, which includes ensuring our venue is safe and accessible. This project will eliminate a major accessibility barrier and improve the safety of our venue, allowing us to better serve our community.

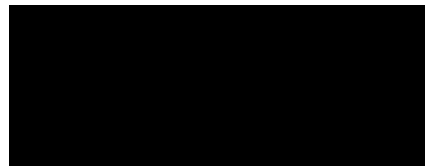

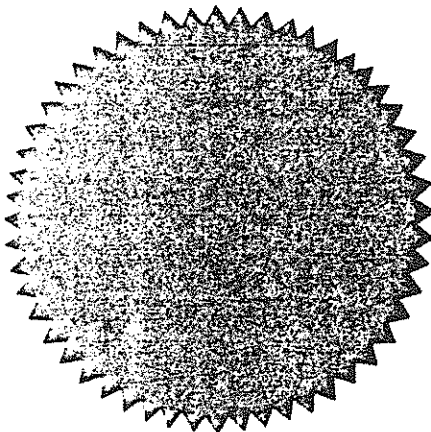

Community Art Days is a popular and expected annual event that our entire institution works to continuously transform and expand every year, providing exciting new offerings in combination with beloved fan favourite staples and creating opportunities for our community to experience artists from across disciplines and geographies. The event brings together visual and audio artists, community members, various non-profit organizations across the city and local vendors, imbuing our downtown core with liveliness and providing a safe, barrier-reduced space for folks from any socio-economic background. This year the event is facing a large transformation, as we shift Community Art Days in light of our upcoming HVAC replacement project this Spring. We are unable to host our usual two-day event in the Canada Games Plaza, and so we are using this year's Community Art Days to be Pollinators for the broader region, bringing artist-in-residences to amplify and draw greater audiences to the amazing events our neighbouring institutions, and institutions within the Regional District that we serve deliver throughout the Spring and Summer.

The 2026 edition of Community Art Days, Pollinators, aims to transform our typical two-day art-making festival into a series of meaningful engagements with community partners at their signature events. Each art engagement will be created in partnership with the community organizations, ensuring that we select our artist-in-residences' activations in alignment with the themes and missions of each institution. We plan to kick off Community Art Days: Pollinators at WALK PG, on May 31 and to wrap up our series at the Prince George Public Library's Touch A Truck event this August, engaging in a total of six partnership events this Summer. This event transformation provides the opportunity to expand our capacity to deepen relationships with neighbouring institutions and allows us to accommodate greater engagement to a broader audience and a larger portion of the region the Gallery serves. Furthermore, it ensures we provide the opportunity for cross-pollination among artists and community members that is the core mandate of Community Art Days. While this transformation comes out of necessity, given our limited access to our building and uncertain construction timelines, Community Art Days: Pollinators, gives us the unique ability to uplift our neighbours and go directly to new audiences, hopefully increasing awareness of, and participation from, folks further afield at future Community Art Days.

Our event emphasizes deep collaboration with other Regional District sites, and activates audiences across the Regional District of Fraser-Fort George. This year we will build our attendance figures by reaching new audiences with our Community Art Days: Pollinators series through these deep community collaborations. We will continue expanding our demographics by offering artist-in-residence activations at youth focussed events like Huble Homestead's Kids Carnival, as well as larger art festivals geared to adult audiences like Island Mountain Arts' ArtsWells. We will continue to build new audiences through our commitment to engaging diverse artists-in-residence's and art activations. Pollinators will engage in a variety of themes and subject matter through meaningful collaboration with our community partners, creating our activations' specifically to enhance the goals of their own institutional events. Community Art Days is a popular and expected annual event that our entire institution works to continuously transform and expand every year, and this year will give us the opportunity to take it on tour! While many of the events will take place off-site, we will be partnering with Tourism Prince George to host a re-opening event for the Gallery in the Nanguz'An Container Market this Summer, enabling us to imbue the downtown core with the ample foot traffic and positive energy expected as a result of Community Art Days. Additionally, hosting this engagement with Tourism PG will ensure folks are still able to enjoy this expected annual festival, albeit on a smaller scale, in its usual location. Furthermore, one of our engagements will work with the Prince George Conference and Civic Center, promoting our City through highlighting the artists behind their upcoming Mural Project, and allowing the community to uniquely engage with this newly revealed public artwork. Finally, we will enhance our neighbouring institutions' annual events, ensuring we continue to highlight the many social and cultural resources available in Prince George.

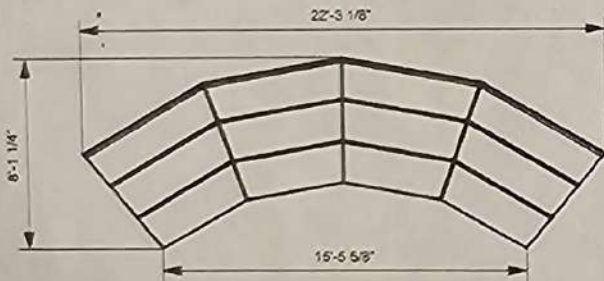

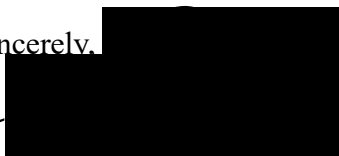

## **PROJECT DESCRIPTION**

### **MOURNING AFTER: PRODUCTION TOUR**

Wishbone Theatre is requesting funds from Regional District Fraser Fort George to help support artist and touring costs to bring our show MOURNING AFTER to the Prince George Playhouse April 24<sup>th</sup> and September 25<sup>th</sup> & 26<sup>th</sup> 2026.

After delivering original theatre pieces to our Robson Valley audiences since 2008, Wishbone is now committed to expanding our audience reach to communities outside the valley. Our first foray was a successful run of our show – LIMELIGHT- An Ode to Vaudeville at the Pavilion Theatre in Kamloops in February 2025. Building on this momentum, we are focussing on developing audiences in the Northern interior and have scheduled MOURNING AFTER for three shows at the Prince George Playhouse in 2026. This marks the first time Wishbone will present work to Prince George audiences, and we are excited to bring our local artists together for this ambitious and timely production, offering a topical piece for community engagement.

We are grateful for the funding we received from RDFFG in 2025 which supported the creation of MOURNING AFTER, and we are currently in rehearsal for the show, opening in Valemount and McBride April 10<sup>th</sup> & 11<sup>th</sup> and April 17<sup>th</sup> & 18<sup>th</sup>.

Following our local performances, we are excited to realize our goal of reaching new audiences by touring our production to the Prince George Playhouse April 24<sup>th</sup> and September 25<sup>th</sup> & 26<sup>th</sup> 2026. We are also percolating plans to bring the show to additional Northern B.C communities in 2027, engaging and networking with new audiences and artists. We believe the topical themes of MOURNING AFTER have a theatrical urgency that will resonate with both our local audiences and audiences outside the valley.

Wishbone has engaged 11 multi-disciplinary theatre artists for MOURNING AFTER, to explore themes of social justice, with a story-line threading through music, song, dance and physical theatre. The play follows characters representing our human need for power and conquest vs our need for love, compassion and social justice. Our goal is to present a musical theatre piece exploring how we navigate the sweeping global changes that are occurring in our world today- climate change, the effectiveness of democracy, dwindling resources, corrupt power systems capitalizing on human frailty, and how these issues resonate through a small communities and their connection to the wider world.

2026 marks the 18<sup>th</sup> year Wishbone has been delivering original theatre creations in the Robson Valley, and the 23<sup>rd</sup> year in communities throughout B.C. With each show, we strive to develop deeper bonds with our audiences and draw in new creators who want to culturally contribute to their community. Each creation is an education process where we search for ways to boost our audience appeal and act as a catalyst for community engagement. Our work engages a diverse age range of local artists, includes gender and ethnic diversity, appeals to a broad spectrum of community, and strives to challenge, entertain and be relevant to our audiences. It increases community awareness and appreciation of theatre art and supports local artists by providing a framework for creation and collaboration. Funds go to artists to help sustain themselves while pursuing their art. Wishbone works to make connections with arts/business organizations to nurture supportive relationships. We encourage local leadership and local entrepreneurs to invest time and resources in their arts community.

Wishbone's theatre presence in the Robson Valley has seen a steady increase in support and enthusiasm for the arts, cementing our cultural place here. With our 2026 theatre programming, we continue to build on this momentum, engaging both new and veteran theatre, dance, and music artists who want to create theatre for our community. Our more recent vision is to expand our creative network outside the valley – creating reciprocal relationships with artists throughout B.C.

## **ACCESSIBILITY and INCLUSIVITY:**

All our venues are wheelchair accessible. For our Senior matinees, we offer free transportation to and from the venue, as well as for attendees with disabilities or no vehicle. This is an important component to our productions, as we are a rural area with no public transportation and some of our audience live out of town.

Our cast and crew are spread out over 90 highway kilometres, and scheduling rehearsal times is always a daunting task, especially through winter months. We make carpooling, gas vouchers and maintaining flexibility a priority. Our rehearsal space is centrally located in Dunster (between Valemount and McBride), where we create a safe, supportive environment for all artists to nurture the creation process.

Our ticket prices respect the economic environment of our community – we believe it is more important to have a full house than a full pocket.

We publicly acknowledge to our audiences that we gratefully and respectfully live and operate on the unceded, traditional Indigenous lands of the Simpcw and Lheidli T'ennah nations.

As artistic producer of Wishbone Theatre, I imagine my plays respectful and mindful of the community I am striving to connect with. Our productions take many months to put together, and involve making connections with artists, local businesses, and social organizations to collaborate under Wishbone's umbrella. Through the power of art, I acknowledge the value of sharing ideas, and I embrace diversity, equity and inclusiveness in my artistic practice. It is vitally important to create a respectful and supportive work environment for all players, mindful of the collective energies of the group. The fine line between leadership and collaboration is a beautiful and fragile dance, and I base it on utmost respect for artist's creative contributions. I work to create an environment in my play productions where people, regardless of age, gender, and ethnicity can hone their artistic skills with hope and courage and expand our ideas of how theatre creation can resonate with our community.

Born and raised in Valemount and surrounding areas, guitarist, singer/songwriter, Seth has performed with several bands in B.C. as well as his own, from MammaGuroove, Samson and Delilah, and most recently **Dream Heavy**, with his partner Shara Gustafson.

Described by fans and reviewers as “Unique, fearless, soul-full world folk music,” Dream Heavy is fronted by partners Seth Macdonald and Shara Gustafson and an eclectic mix of violin, bass, and drums provided by a core group of their favourite B.C. musicians. They are a festival favourite on the B.C. music festival circuit and also perform at independent concert series, numerous clubs and independent music venues throughout western Canada. In addition to writing and performing their own music, the duo are also the main organizers of “The Robson Valley Music Festival,” a 3-day multi discipline arts event held annually on their rural property along the headwaters of the Fraser River.

With strong messages in their lyrics, the duo has consistently stood in solidarity with marginalized persons or groups within our society. They broadcast messages of social justice, advocate for action on climate change, the protection of our natural world and strongly protest totalitarian ideas and systemic racism.

Seth has performed as an actor and musician in several Wishbone Theatre plays written by Sharon Stearns, notably HUNTER OF PEACE, and most recently as guitarist and singer in their 2024 production of LIMELIGHT – An Ode To Vaudeville. He collaborates with Sharon by composing the music for her lyrics on many of her plays. He is thrilled to be engaged in a musical collaboration with Stearns and Wishbone Theatre artists on MOURNING AFTER – A ROCK MUSICAL, and excited to explore the challenging social and political issues our world is facing through an artistic lens.
