SERVICE DESCRIPTION:

The Regional District Board is authorized to provide Economic Development services to the region and to fund these services through Bylaw No. 804, 1986.

The Board considers funding specific Economic Development projects or initiatives with third parties such as the current contract with the City of Prince George for their marketing work on the Industrial Lands Project, collaborative project with the Village of McBride and the Village of Valemount regarding the Robson Valley Region program and projects that benefit the electoral areas and neighboring communities.

For the past number of years, the budget has been funded through a grant-in-lieu targeted for Electoral Area Services and has not required any requisition funding.

BUDGET INFLUENCES/SIGNIFICANT VARIANCES:

- Reduction in budget from 2023 to 2024 as a result of completion of investrvr.ca website project, reduced grant funding for the 2024 Business Facade Improvement Program and reduced expenditure projected in training and development
- budget recognizes prior year surplus, along with a \$90,000 grant-in-lieu contribution and combined grant funding from Northern Development Initiative Trust of \$65,000 that offsets the need for funding from requisition for 2023
- budget reflects funding allocated to the implementation of recommendations resulting from the Regional Agriculture Strategy
- budget reflects the long-term partnerships for the delivery of economic development initiatives with the City of Prince George, Village of McBride, Village of Valemount and Cleanfarms Inc.
