- operating reserve funds utilized to cover 2022 deficit as per legislative requirements.
- cost of attendance at Union of BC Municipalities, North Central Local Government Association, Federation of Canadian Municipalities and TransCanada Yellowhead Highway Association annual conventions is budgeted for all seven electoral area directors.
- a portion of two Corporate Services staff salaries and benefits assigned to the budget to reflect work done on behalf of electoral areas.
- 35% of Electoral Area Director remuneration is funded by this budget and under "Regional Board Remuneration Bylaw No. 3119, 2019", as amended.
- annual Consumer Price Index (CPI) increases have been included in Director remuneration.
