To Whom it may concern,

I am contacting you, as a spokesperson on behalf of the Pineview Community. The purpose of this letter is to get the action, and the resources needed to ensure the safety of our community members . Whether that be more policing, arrests, or changes to the judicial system. We as a community no longer feel safe in our own homes, and are constantly on alert for our safety, as well as that of our neighbours . We need actions not promises. We need criminals to remain in custody, not released into public to continue putting others at risk repeatedly.

I recently witnessed an alarming event just next door to our home. It took place in broad day light on a Sunday at noon. I had been asked to keep a close eye on my neighbours place as she had already had a break-in a week or so earlier. She is an [REDACTED] with [REDACTED] [REDACTED] and [REDACTED] .

I witnesses two male individuals cutting through an adjoining property, crossing our field and continuing to My neighbour's. They we carrying various items but the one that caught my attention the most was a machete! They continued to walk over to my [REDACTED] neighbours property. When they reached the outside of her home they covered their faces with masks and made their way into her garage. The police were called and responded quickly. Luckily, this time, no-one was hurt. The two criminals are know to police and some of the community. These criminals have been caught and releases repeatedly.

Another neighbour of mine had his truck and trailer full of work equipment stolen recently! He contacted me yesterday angry that a cab company had come onto his property to pick up trespassers who were casing out his place.

The above mentioned is only a few of many incidents that have occurred far too frequently. I have Community members that are absolutely disappointed and disgusted with the entire legal system.

I am contacting you in hopes that you will do your diligent duty and help protect us all, whether that be increased police presence, end the so called safe drug supply. Make changes to the present catch and release practices. Protect home owners and their personal possessions!

My hope is for no-one else to suffer a tragic event similar to what took place in the Beverly/Mud river Community where the home owner came home to witness a break in then was dragged under a truck, and now with broken ribs looking at facial reconstruction and possible limb amputation! I respectfully request you do everything in your power to change the current state of affairs! Please! Help!
