Please find attached two letters advising your government of the proposed ministerial orders to expand Ungulate Winter Range (#u-7-001) and create a new Wildlife Habitat Area (#7-018).

Both of these ministerial orders relate to the herd of Southern Mountain Caribou known as the Kennedy Siding herd, which has a territory that is located approximately 25 km Northeast of Mackenzie, BC.

The letters provide links to two BC Box sites, both of which include background and details on the species, the ministerial orders and the spatial data for these sites. I have also attached a kmz file for each of proposed protected areas.
