SERVICE RELEVANCE:

The Regional District's current Community Grants-In-Aid program derives its authority from the *Local Government Act*. The purpose of these functions is to provide financial assistance to community groups or organizations which, in the opinion of the Regional District, provide a benefit to the community.

The Recreation function was established in 1975 to assist community associations in electoral areas to provide recreation within their program boundaries. The current participants in the Recreation service are Electoral Areas A, C, D, E, and F. In 2005, the Fraser-Fort George Recreational Program Establishment Bylaw was amended by Bylaw No. 2203 which altered the funding formula to each electoral area to fund its own programs exclusively.

FINANCIAL CONSIDERATION(S):

The 2025 budgets for Community Grants-In-Aid Electoral Area E and Recreation Grants Electoral Area E would support these expenditures.

If the Board does not wish to provide one or more of the grants listed, a motion to amend the Schedule prior to voting on approval of the Schedule would be in order.
