BYLAW NO. 2801

**A BYLAW TO AUTHORIZE THE IMPOSITION OF A PARCEL TAX WITHIN
ELECTORAL AREA A FOR THE PURPOSE OF FUNDING A STREET LIGHTING
SERVICE**

WHEREAS the Regional District may, pursuant to Section 200 of the Community Charter, impose a parcel tax on real property;

AND WHEREAS the Regional District has, by Bylaw No. 1654, established the Syms Road Street Lighting Service within Electoral Area A;

NOW THEREFORE the Board of Directors of the Regional District of Fraser-Fort George, in open meeting assembled, enacts as follows:

Interpretation

1. In this bylaw, unless the context otherwise requires:

“**owner**” means the current owner or a previous owner of a parcel.

“**service**” means the Syms Road Street Lighting Service.

“**service area**” means the geographic area included in the service, as amended from time to time.

2. (1) Beginning in the year 2023 and annually thereafter, there shall be caused to be prepared a parcel tax roll, to be known as the Syms Road Street Lighting Parcel Tax Roll, containing all taxable parcels of real property within the boundary of the Syms Road Street Lighting service area which are capable of being connected to the street lighting system.
- (2) A parcel tax is hereby imposed for each parcel included in the Syms Road Street Lighting Parcel Tax Roll in the amount of \$94.44.
- (3) The parcel tax authorized under this bylaw shall be the same amount for every parcel regardless of the area or dimensions of the parcel.

Citation

3. This bylaw may be cited for all purposes as “Syms Road Street Lighting Service Parcel Tax Imposition Bylaw No. 2801, 2013”.
