Re: Land Act – Transfer of Administration and Control to Simpcw First Nation

Further to our letter dated October 18, 2018 and your support letter of April 21, 2022, I am writing to notify you that MOTT, in collaboration with the Ministry of Water, Land and Resource Stewardship (WLRS), is proceeding with the Land Act - Transfer of Administration and Control and the associated administrative decisions regarding the subject lands described as:

- Site 1 (7.69 hectares) – Lot 1, District Lot 480, Plan EPP89342 (108794 CLSR)

We are sending you this update letter to keep you informed on the process as it moved forward. On completion of the Land Act – Transfer of Administration and Control to Canada, the land will be added to reserve for use and benefit by the Simpcw First Nation.

If you have any updated information that may inform how these decisions may impact your interests, please contact me by April 4, 2025 to enable the Province to consider such information in relation to its decision making.





Parcel A1



The Regional District welcomes the opportunity to continue to meet with Simpcw First Nation as plans for the area are developed and opportunities to work together and collaborate are identified. As a reminder, the Regional District currently does not provide the following services in that area:

- Fire protection
- Sewerage system or potable water system service
- Refuse disposal site
