**A BYLAW TO AMEND ROBSON VALLEY-CANOE UPSTREAM OFFICIAL COMMUNITY PLAN BYLAW NO. 2290, 2006**

**WHEREAS** pursuant to the *Local Government Act*, the Regional Board of the Regional District of Fraser-Fort George has, by Bylaw No. 2290, dated March 22<sup>nd</sup>, 2007, adopted Robson Valley-Canoe Upstream Official Community Plan;

**AND WHEREAS** the Regional Board intends to amend aforesaid Bylaw No. 2290, 2006 by passage of this bylaw, pursuant to the requirements of the *Local Government Act*;

**NOW THEREFORE** the Board of Directors of the Regional District of Fraser-Fort George, in open meeting assembled, enacts as follows:

1. Robson Valley-Canoe Upstream Official Community Plan Bylaw No. 2290, 2006 is hereby amended as shown on Appendix 'A' attached to and forming part of this bylaw.

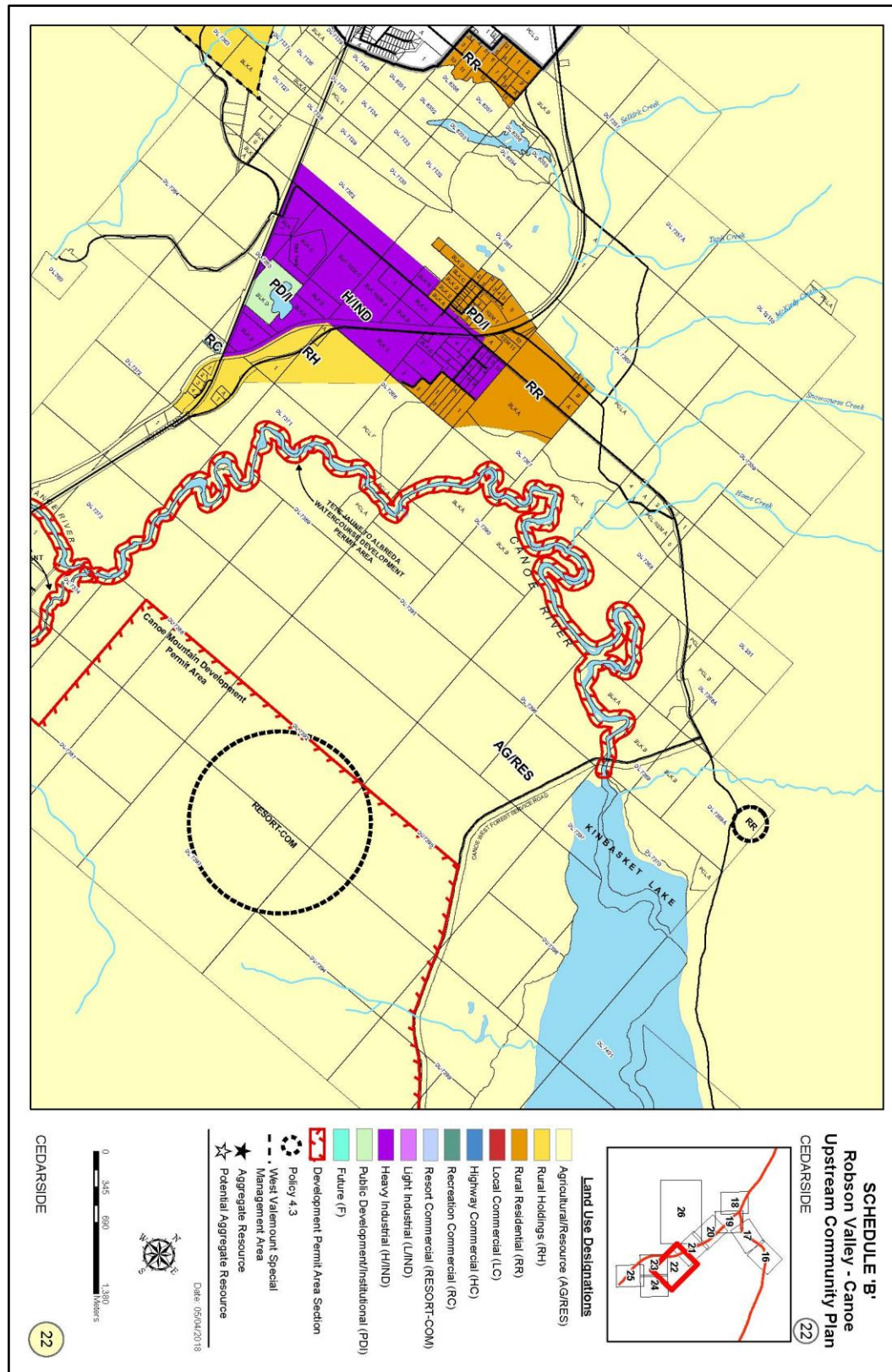

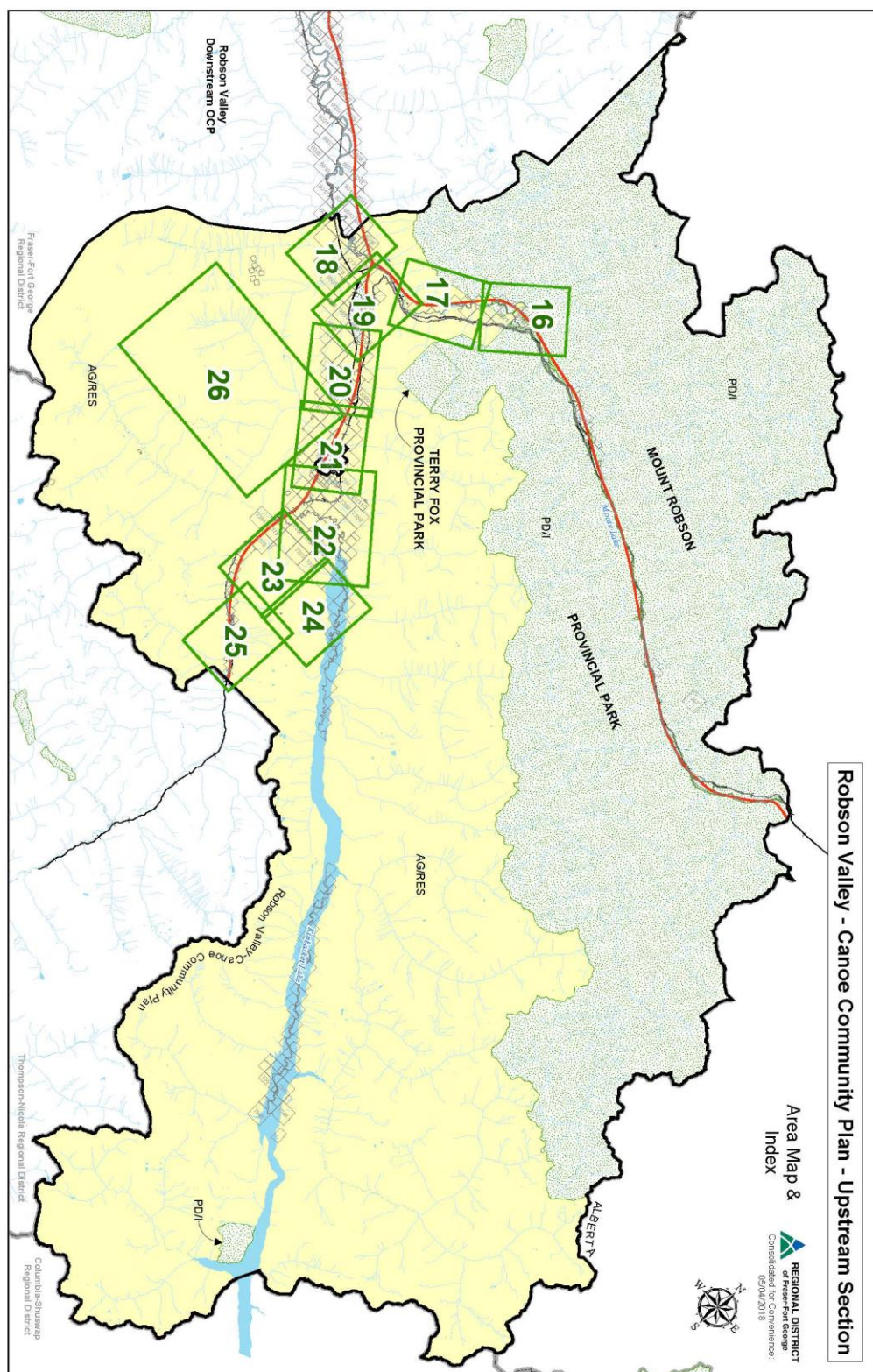
